- Corruption Watch is a civil society organisation that opened its doors to the public in January 2012. We are registered as a non-profit company in terms of the Companies Act, 71 of 2008.
- 2. Corruption Watch seeks to expose corruption and the abuse of public funds. We aim to expose those who engage in corrupt activities, nepotism and abuse of public funds in both the public and private sector are held to account.

ensure that, in the public interest, these concerns are fully ventilated and considered

at the AGM.

open and transparent manner for the benefit of all South Africans and in the interest

of promoting transparency and accountability.

7. We intend attending this meeting. Please advise as to time and venue of the

meeting and confirm that we will be admitted.
