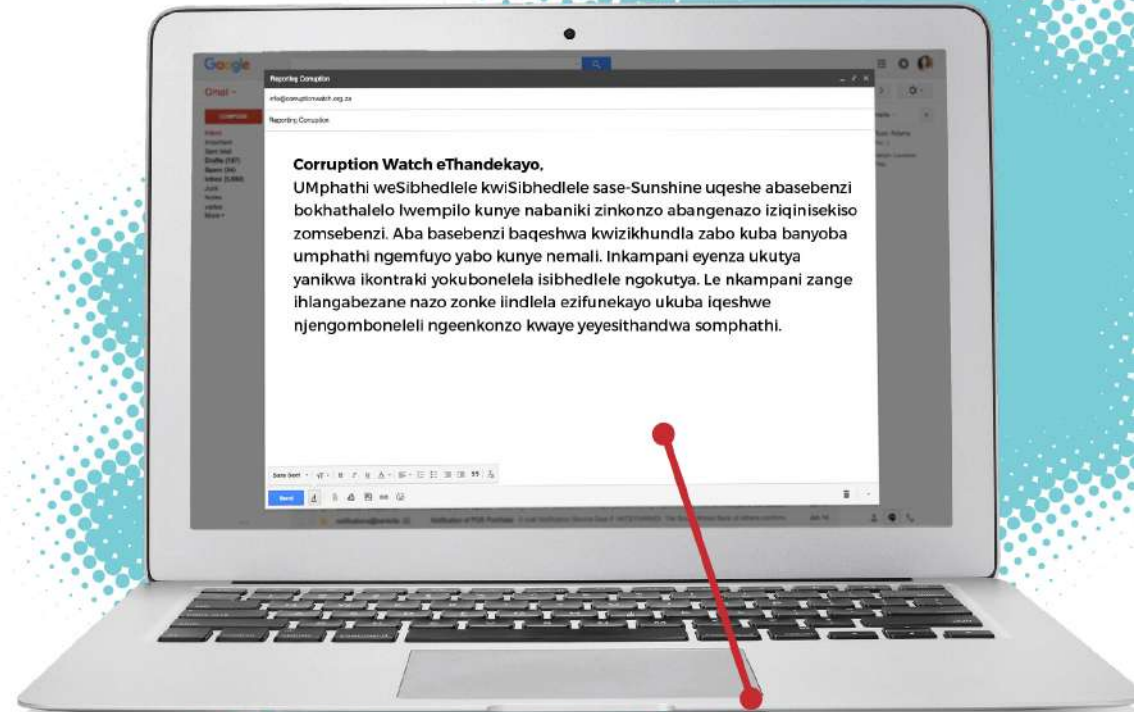
Ukuqinisekiswa kwesibonelelo sokhathalelo lwempilo ngokungafanelekanga
