- We refer to the above matter and hereby confirm that the legal representatives of the parties involved in the application have agreed to approach Your Lordship with a proposal for an appointment of a Judge for case management.
- The Applicants, Corruption Watch and Right 2 Know, represented by Harris Nupen Molebatsi Inc Attorneys, launched an application seeking the review and setting aside of the findings of Arms Procurement Commission.

- 3. The Application was launched in about October 2017. The Respondents in the Application are all represented by the State Attorney, Pretoria. The Applicants have as in the nature of review applications, called upon Justices Willie Seriti NO and Hendrick Mmolli Thekiso Mmusi NO, the chairperson and the Commissioner respectively to deliver a record of proceedings. Due to the duration of the commission and the magnitude of volumes of documents run into thousands of documents which were provided to the commission, the State Attorney filed the record towards the end of March 2017 in an electronic format.
- 4. The Applicants after going through the record, delivered a notice in terms of rule 30A(1) in the beginning of June 2017 requesting the delivery of further documents which they believe are in possession of the Respondents. The Respondents experienced difficulties in the production and delivery of the further documents sought by the Applicants and the latter ultimately delivered a notice in terms of rule 30A(2) to compel compliance with delivery of further records. These is mainly for two reasons:
  - a. These documents were not before the commission and as a result are not indexed and paginated. They are also not in a particular order. Hence, to obtain a particular document one has to go through thousands of documents.
  - b. The process is studious and time consuming taking into account that we have other matters to attend to. Respondents have engaged the services of two junior Counsel to assist in this regard in order to expedite the process of complying the request.

- The notice to compel compliance in terms of rule 30A(2) was set down for the 27<sup>th</sup> November 2017. At the hearing of the notice, the Respondents advised of their intention to oppose the application and this led to the removal of the matter from the roll with costs reserved.
- 6. The parties agreed after the removal of the matter from the roll to refer the matter to Your Lordship for case management. The case management process which we contemplate is to have regular and structured meetings on the direction of the court to regulate the delivery of pleadings and other related matters up to and including possible hearing dates.
- 7. The parties have in the meantime among themselves agreed to give the Applicant's legal representatives regular access to documents for inspection and identification of the record specified in their rule 30A(1) notice. The process will proceed until the documents have been identified and produced for the purpose of the record.
- We request your Lordship to consider our request and we will be available to attend a meeting should we be so directed.

## Corruption Watch and Right2Know / The Arms Procurement Commission and Six Others 81368/16

1. We refer to the discussions which took place at the High Court and in particular to paragraph 7 of your letter dated 27 November 2017 to the Deputy Judge President. For ease of reference, paragraph 7 reads as follows:

"The parties have in the meantime among themselves agreed to give the Applicants' legal representative regular access to documents for inspection and identification of the record specified in their Rule 30A(1) Notice. The process will proceed until the documents have been identified and produced for the purpose of the record".

- In paragraph 4a of your letter, you state that "The Respondents experienced difficulties in the production and delivery of further documents sought by the Applicants .... mainly for two reasons,.... <u>These</u> documents were not before the commission and as a result are not indexed and paginated. They are also in a particular order. Hence, to obtain a particular document, one has to go through thousands of documents...".
- 3. Our clients have considered your proposal to allow them "regular access to documents for inspection and identification of the record" specified in our clients' Rule 30A(1) notice. Our clients believe that such an exercise may cause further and unnecessary delay. Our clients are entitled to copies of "the record" of the Commission in terms of Rule 53. If

documents "were not before the Commission", then it would appear that they are not part of the record. In that event, no purpose would be served by our clients inspecting them.

- 4. To summarise, the position is as follows:
- 4.1. Your clients are required to produce the record of the Commission. It is not for our clients to search through files and attempt to identify what was and was not before the Commission. It is for your clients to say what was before the Commission, and to produce it.
- 4.2. Our clients require your clients at the very least to produce the documents listed in the annexure hereto, which formed part of the Rule 30A(1) notice. All of those documents self-evidently were before the Commission, because they are referred to in the Report of the Commission. The annexure now includes a column which identifies the place in the Report where reference is made to the listed documents.
- 4.3. Our clients also require your clients to produce the documents which were provided to the Commission by SAAB: we refer in this regard to Volume 1 of the Report, Chapter 2, section D(1). The documents required include but are not limited to:
  - 4.3.1. SAAB's internal investigation into the 'SANIP issue', with supporting documents provided to the Commission by SAAB;
  - 4.3.2. All agreements entered into between SAAB and SANCO and/or NUMSA;
  - 4.3.3. Minutes of meetings between SAAB and SANCO and/or NUMSA;
  - 4.3.4. All agreements entered into between SAAB and third parties relevant to the SDPP:
  - 4.3.5. All correspondence between the Commission and SAAB;
  - 4.3.6. Any submission or witness statement by SAAB to the Commission.
- 5. Would you kindly let us have copies of the following as a matter of urgency:
- 5.1. The further documents which your counsel have identified as part of the record.
- 5.2. The documents listed in the annexure hereto;
- 5.3. The documents listed in paragraph 4.3 above.
- We agree that it is desirable that the DJP should place the further conduct of this matter under case management. We shall also write to him in this regard, and shall copy you on that correspondence.



- We refer to the above matter, and to the numerous requests made by our offices to be granted access to the record for inspection. We confirm that:
  - 1.1. In accordance with a request made by ourselves to your offices, our clients were granted access to inspect the record for the above matter on 23 March 2018, at the Offices of the State Attorney;
  - 1.2. We advised you in correspondence from our offices to yourselves dated 5 April 2018, that the documents you had set aside for the inspection unfortunately did not match the record requested, and as such, you agreed to allow our client to inspect the record of the Commission and extract the documents requested in the Rule 30A(1) Notice over an extended period of time;
  - 1.3. In your letter dated 6 April 2018 with reference number 8080/2016/Z75, you indicated that you intended to have all the documents collated by 30 April 2018, and that you would advise us regarding scheduling a date for inspection closer to the time;
  - 1.4. In response thereto, we sent correspondence to your offices dated 6 April 2018, wherein we stated that under Rule 53 you are obliged to produce, and we are entitled to inspect, the whole of the record of the Commission, and requested that you provide us with a date and time suitable for our clients to attend to the inspection of the record;

- 1.5. No response was received to the abovementioned correspondence, and as a result of a telephonic conversation between yourselves and Ms B Molebatsi on 4 May 2018, you sent correspondence from your office to ourselves dated 7 May 2018, wherein you stated that you had completed identifying two thirds of the documents listed in the Rule 30A(1) notice, and that you would make the documents available for inspection once the process had been completed;


