3. Criminal Charges

3.1 As explained in our letter, our client laid criminal charges against Mr Tom Moyane for violations of PRECCA and FICA, and Mr Jonas Makwakwa and Ms Kelly-Ann Elskie in respect of FICA offences.

3.2 In a letter to us dated 27 March 2018 a copy of which is attached marked "Q" the DPCI has now indicated that:

3.2.1 the NPA is not proceeding with the prosecution of Mr Moyane in respect of the allegations for contravention of section 34 of the Prevention and Combatting of Corrupt Activities Act and the allegations for contravention of sections 29(4), 60(1) and 60(2) of the Financial Intelligence Centre Act; and

3.2.2 the cases in respect of Mr Makakwa and Ms Elskie are still under investigation, bank statements from financial institutions and affidavits from witnesses have been obtained and there has been ongoing consultation with the Prosecutor allocated to deal with the matters and more evidence still to be obtained.

3.3 In the circumstances we make the following demands:

3.3.1 that a certificate of *nolle prosequi* in respect of the charges laid against Moyane, under PRECCA and FICA, be issued to our client within 2 weeks of 23 March 2018; and

3.3.2 concerning the cases of Makwakwa and Elskie for decision, full details of progress of the matters is requested within 2 weeks of 23 March 2018.
