FOUNDING AFFIDAVIT: CONDONATION APPLICATION

I, the undersigned,

## **NUNTHAKUMARIN PILLAY**

do hereby make oath and state as follows:

I am a major male and director of the applicant ("CPS") which was the third respondent before the High Court.



- The facts contained in this affidavit are within my personal knowledge, save where the contrary clearly appears, and are to the best of my belief both true and correct. Where I make legal submissions, I do so on the advice of my legal advisors.
- This is an application for condonation for the late filing of the applicant's application for leave to appeal against the judgment and order of the Supreme Court of Appeal ("SCA") (per Plasket JA) in case 1029/2018 delivered on 30 September 2019 ("the Judgment").
- After considering the Judgment, the applicant made the decision to brief new attorneys in order to consider its position and advise on any further course of action. Mr Alexander Smith and I of the applicant met with the applicant's new attorneys, Stein Scop Attorneys Incorporated ("Stein Scop") for the first time at 12:30 on Friday, 11 October 2019. At that preliminary meeting the prospect of an appeal to the Constitutional Court of South Africa was raised by Stein Scop.
- After considering this over the weekend, the applicant advised its erstwhile attorneys, Smit Sewgoolan Incorporated ("Smit Sewgoolam") that it was terminating their mandate on Monday, 14 October 2019. On that same day, the applicant consulted with Stein Scop in order to properly brief them on the matter.
- On the afternoon of Monday, 14 October 2019 Mr Glenn Stein of Stein Scop phoned Mr Tiaan Jonker of Smit Sewgoolam in order to arrange collection of the files in respect of the matter from Smit Sewgoolam in order that Stein Scop

might brief counsel to prepare the application for leave to appeal. Mr Jonker advised Mr Stein that he would set up a DropBox that afternoon containing the appeal record so that Stein Scop could access the files as quickly as possible. A confirmatory affidavit deposed to by Mr Stein is delivered herewith.

- Ms van der Weele of Stein Scop followed up this phone call with an e-mail to Mr Jonker in which she requested copies of the appeal record and the parties' heads of argument. Mr Jonker replied that he was waiting on a formal written instruction from the applicant and would upload the requested documents to a DropBox folder as soon as they received same. A copy of that e-mail chain is attached, marked "A".
- Mr Jonker failed to provide Stein Scop with the DropBox details and instead sent an e-mail to Stein Scop on Tuesday, 15 October 2019 attaching the parties' heads of argument and advising that two sets of the appeal record could be collected by Stein Scop from the reception of Smit Sewgoolam. A copy of that e-mail is attached, marked "B".
- The appeal record was collected by Stein Scop on the morning of Tuesday, 15 October 2019 and copies were made (constituting five volumes) in order to brief counsel.
- Junior and senior counsel were briefed on Tuesday, 15 October 2019 and immediately began reading into the matter and preparing the applicant's application for leave to appeal.

- 11 Counsel circulated the first draft of the application for leave to appeal on the afternoon of Sunday, 20 October 2019, which draft was immediately forwarded by Stein Scop to Ms Anja Lewington of the applicant's for comment.
- Ms Lewington, Mr Smith, Mr Herman Kotze and I considered the draft and spent the morning of Monday, 21 October 2019 discussing and amending the draft in conjunction with Ms van der Weele of Stein Scop as well as senior counsel. The draft was finalised at around 12:30 on Monday, 21 October 2019. After I commissioned the founding affidavit at the Rosebank Police Station, Stein Scop was required to make 25 copies of the application. This process of copying the application took some time, which resulted in the application not being ready for delivery to the Constitutional Court by 15:30 on Monday, 21 October 2019.
- Despite this, Ms van der Weele of Stein Scop e-mailed a copy of the application for leave to appeal to the respondents' attorneys on the afternoon of Monday, 21 October 2019. Copies of those e-mails are attached, marked "C" and "D", respectively. Upon being advised that Mr A Suliman, the lead attorney on the matter at MacRobert Attorneys Incorporated ("MacRobert"), had left the employ of MacRobert, a copy of the application was e-mailed to him as well. A copy of that e-mail is attached, marked "E". The application was also e-mailed to the Constitutional Court, a copy of which e-mail is attached as "F".
- 14 In the circumstances I humbly submit that:

- 14.1 there had been no undue or unreasonable delay in the decision to apply for leave to appeal and the preparation of the application itself, all efforts having been made to deliver timeously;
- 14.2 the late filing of the application by only one day has caused no prejudice to the respondents, who were provided with copies of the application on the due date, being Monday, 21 October 2019 and hopefully no inconvenience to the Court; and
- 14.3 the matter concerns repayment of the sum of R317 million, which is clearly substantial and the applicant would be severely prejudiced if this application for condonation is not granted.

WHEREFORE the applicant prays for an order condoning the late filing of its application for leave to appeal to the Constitutional Court


