## TYPES OF ABUSE OF POWER

- Abusing official capacity for personal gain
- Brutality or violence towards individuals / communities
- Sexual assualt by a police officer, whether the police officer is on or off duty



### **YOU HAVE A RIGHT TO:**



- Have your dignity respected and protected
- Not to be deprived of freedom arbitrarily
- Not to be detained without trial
- Be free from all forms of violence from either public or private sources
- Not to be tortured in any way, or be treated in a cruel or inhumane manner
- Ask police officials for identification
- Take a photo and/or record the conversation with a cell phone



### WHAT TO DO:



• If the abuse is in the form of physical violence and you are injured as a result, first seek medical assistance or call for help. Once you have received medical attention, ensure that you complete a J88 form. The J88 is a legal document that is compiled by a medical doctor or registered nurse, documenting injuries sustained by the victim in any circumstances where a legal investigation / process may follow.



### WHAT TO DO:



- If you are taken to a police station, immediately report any physical abuse to the senior official in charge and ask to call a family member, friend or lawyer.
- Whatever form the abuse takes, make certain that you memorise as much detail as possible about the date, time, place, vehicle registration number, names of officials and witnesses



## WHAT TO DO:



 Contact a legal practitioner or one of the civil society organisations mentioned below as soon as possible for assistance with possible criminal and civil action.



### **IMPORTANT**



It is best to not confront police with an assertion of your rights if you believe that it will aggravate the situation, or if you fear for your physical safety. It is advisable to remain calm and ensure that you memorise as much information as possible, and thereafter lay a complaint with the channels that are provided below.
