



IF YOU ARE ARRESTED,

RIGHT



YOU HAVE A RIGHT TO:



- Be informed by the official making the arrest of the reasons for your arrest
- Be shown a warrant of arrest
- A copy of the warrant
- Remain silent and to be informed of this right promptly and the consequences of not remaining silent
- Not be compelled to make any admission or confession that may be used against you



YOU HAVE A RIGHT TO:



- Be brought before a court as soon as reasonably possible, but not later than 48 hours after arrest
- Be informed of the reason for being detained
- Choose to consult with a lawyer of your choice
- Have a lawyer assigned to you if you cannot afford one
- Challenge the lawfulness of your detention before a court of law
- Be detained under conditions that are consistent with human dignity



YOU HAVE A RIGHT TO:



- Be searched in a decent way and orderly manner. A female may not be searched by a male and vice versa (resistance to a lawful search is an offence)
- To communicate with, and be visited by your spouse, partner, next of kin, religious councillor or medical doctor
- To a fair trial



IMPORTANT



It is best to not confront police with an assertion of your rights if you believe that it will aggravate the situation, or if you fear for your physical safety. It is advisable to remain calm and ensure that you memorise as much information as possible, and thereafter lay a complaint with the channels that are provided below.
