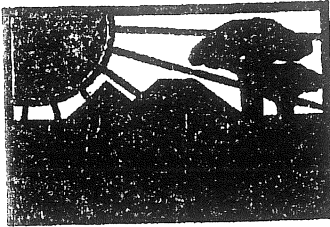

We refer to your land claim lodged with the Commission on the 28th of May 1994. The Office of the Regional Land Claims Commissioner for KwaZulu - Natal gazetted your claim as a community claim after having received another claim by Mr. H. T. Madonsela who was mandated to claim on behalf of the Amantungwa Community.

Several meetings with the affected land owners were held with a view of amicably settling a claim. Objections and representations were brought forward by the land owners disputing the merits of the claim. The major objection is based on a claim form since it states clearly which properties are under claim but the Commission gazetted other properties which are not part of the claim as per the lodged claim forms for Gazette Notice dated 25 June 2004 No. 26477.

Section 2(1)(a) and (d) of the Restitution of Land Rights Act 22 of 1994 (as amended) expressly provides for a person and a community dispossessed of his or their right in

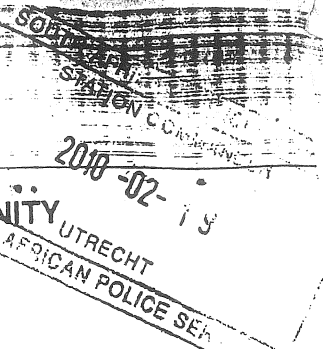
**RESOLUTION TO TRANSFER PROPERTIES FROM THE IZIMBUTHU
COMMUNITY TO AMANTUNGWA DEVELOPMENT TRUST**

We, the elected trustees of the Izimbuthu Community Trust, hereby confirm that a meeting was held with the officials of the Department of Rural Development & Land Reform (PLRO & RLCC) on the 20th January 2010 in Utrecht.

In this meeting, we resolved that all properties acquired through the Restitution program and transferred to the Izimbuthu Community Trust, be transferred to the Amantungwa Development Trust. The reason for this is that the land was originally claimed for Amantungwa Community and the lodger had indicated that properties be transferred to the Amantungwa Development Trust. Also, the existence of two separate entities in one community results into chaos within the community.

The properties to be transferred to Amantungwa Development Trust are:

- Rem. of Portion 1 of the farm Zwartkop No. 91
- Portion 4 of (3) of the farm Politiek No. 67
- Portion 3 of the farm Zwartkop No. 91
- Portion 4 of (1) of the farm Zwartkop No. 91
- Portion 11 of 2 of the farm Zwartkop No. 91
- Portion 0 of the farm Magdalena No. 443
- Portion 1 of the farm Waaikraal No. 153
- Portion 2 of the farm Waaikraal No. 153
- Portion 6 of the farm Vaalbank No. 154
- Remainder of the farm Haatrebeestspruit No. 111
- Portion 15 of the farm Zwartkop No. 91

Remainder of Portion 5 of the farm Haatrebeestspruit No. 111

Portion 6 of the farm Berouw No. 179

We further resolved that the Izimbuthu Community Trust be dissolved and a new board of Trustees be elected for Amantungwa Development Trust once the verification of all beneficiaries, including tenants, has been finalized.
